This role will also involve underwriting, sourcing, and managing debt and equity for our real estate portfolio as well as assisting in sourcing and underwriting new development opportunities. The Asset Manager will play a critical role in helping The Rush Companies optimize and grow their multifamily portfolio and achieve long-term investment goals. The Rush Companies currently owns and manages ~2,300 multifamily units with another ~1,200 units in our pipeline. Our goal is to own and manage 10,000 units in 10 years through acquisitions and development.
